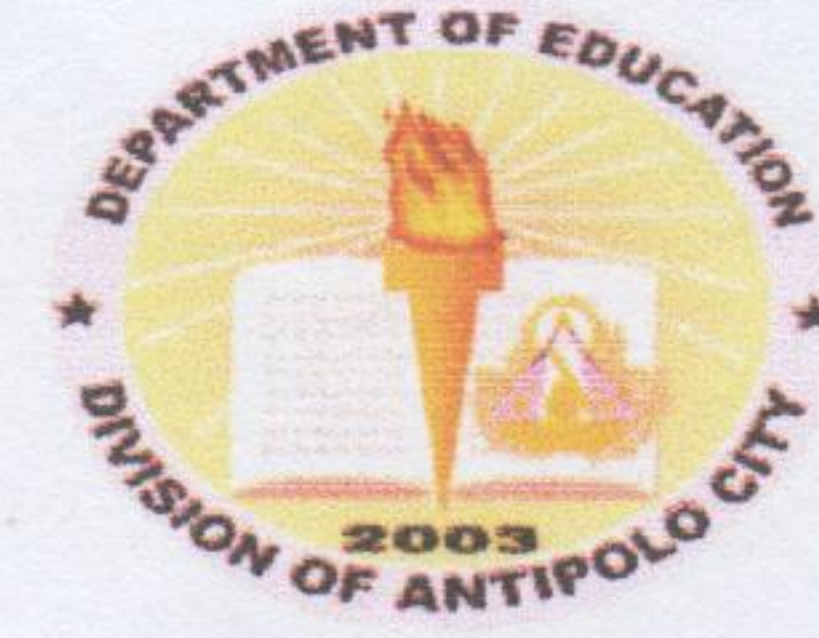


The convention aims to assemble advocates, guidance practitioners, values educators and other counselors from different military branches as well as those in the field of technical and vocational education for career enhancement.

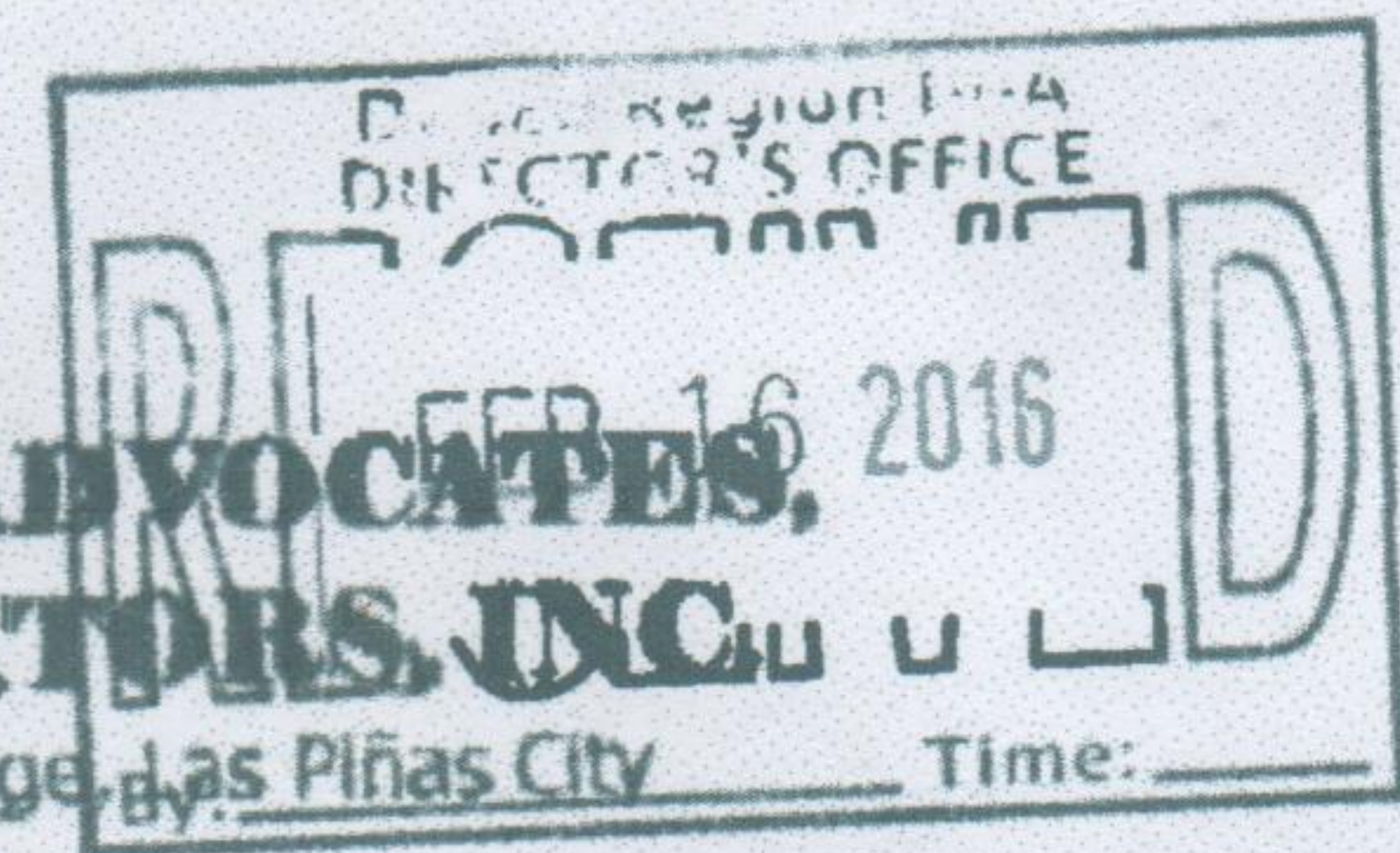

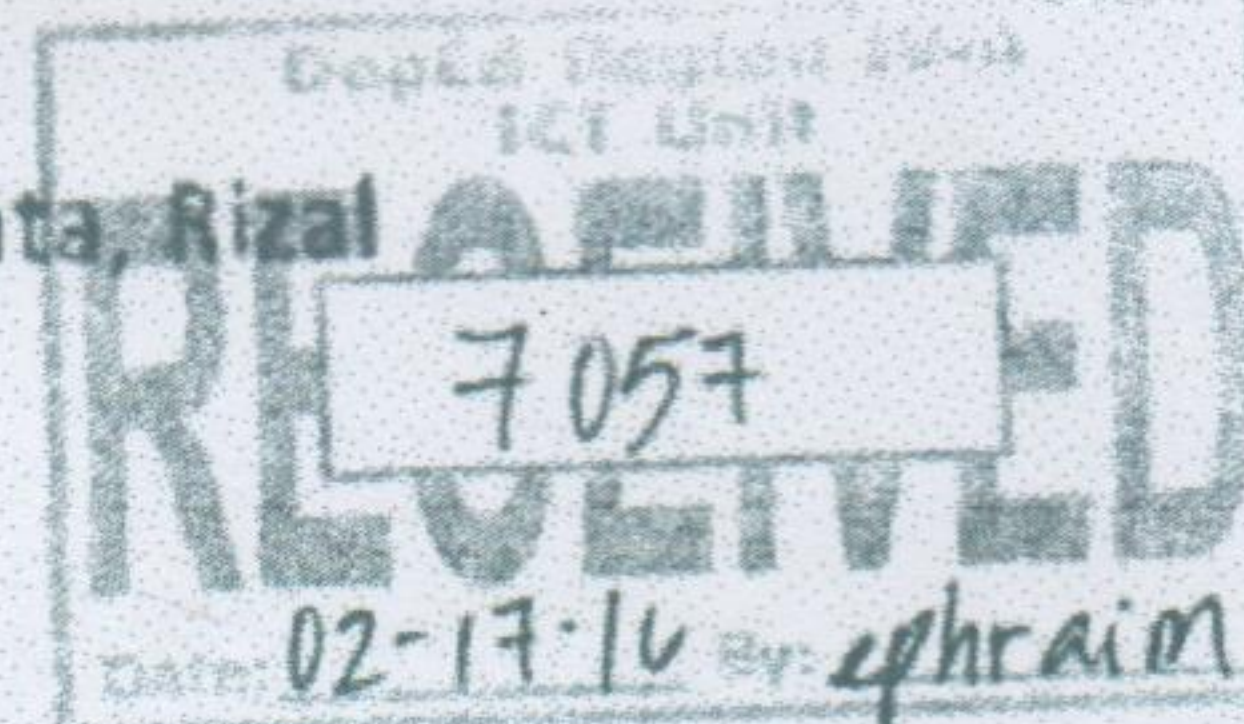
