

Pursuant to DepEd Order No. 3, s. 2016, "*Hiring Guidelines for Senior High School (SHS) Teaching Position Effective School Year (SY) 2016-2017*", English Proficiency Test (EPT) shall be administered to SHS Teacher Applicants by the Bureau of Educational Assessment (BEA) formerly NETRC at San Isidro Elementary School on **Tuesday, February 23, 2016 at 8:00 AM (1st Session) and 10:00 AM (2nd Session)**.
