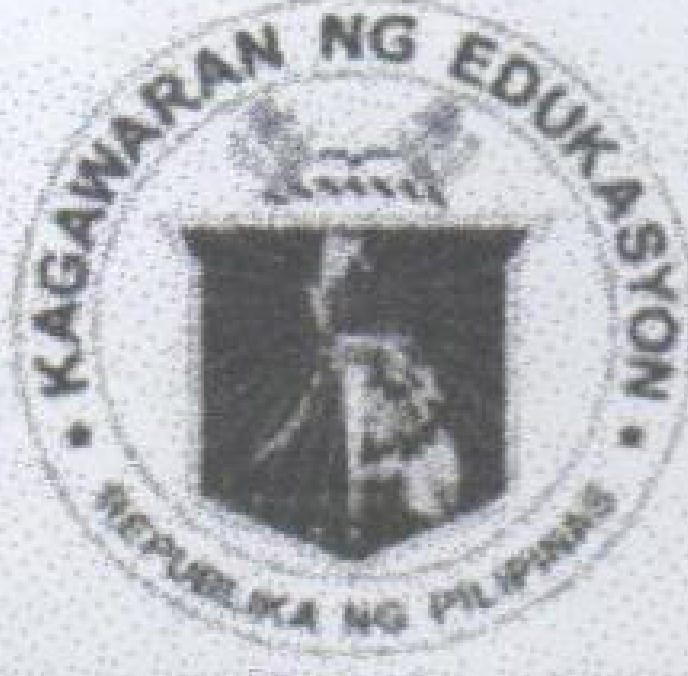
The National School-Based Deworming Day is scheduled on January 27, 2016 Wednesday. Kindly observe the following reminders;

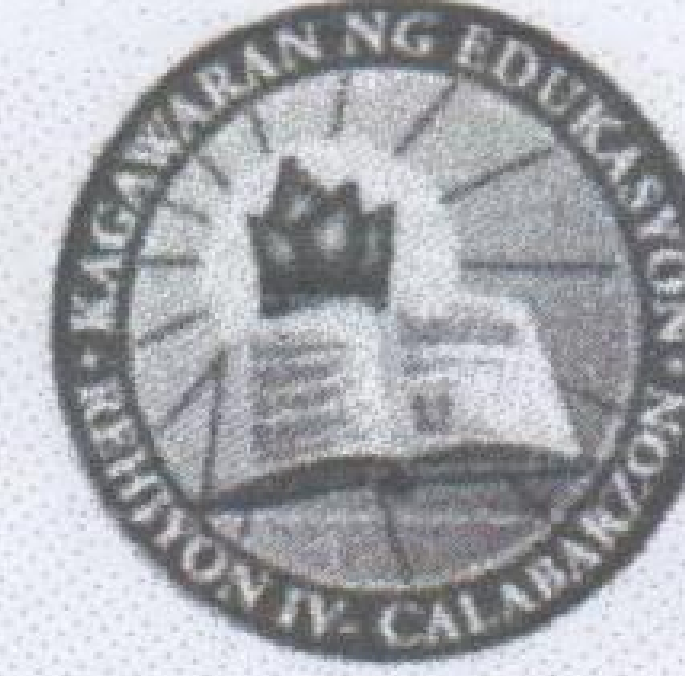

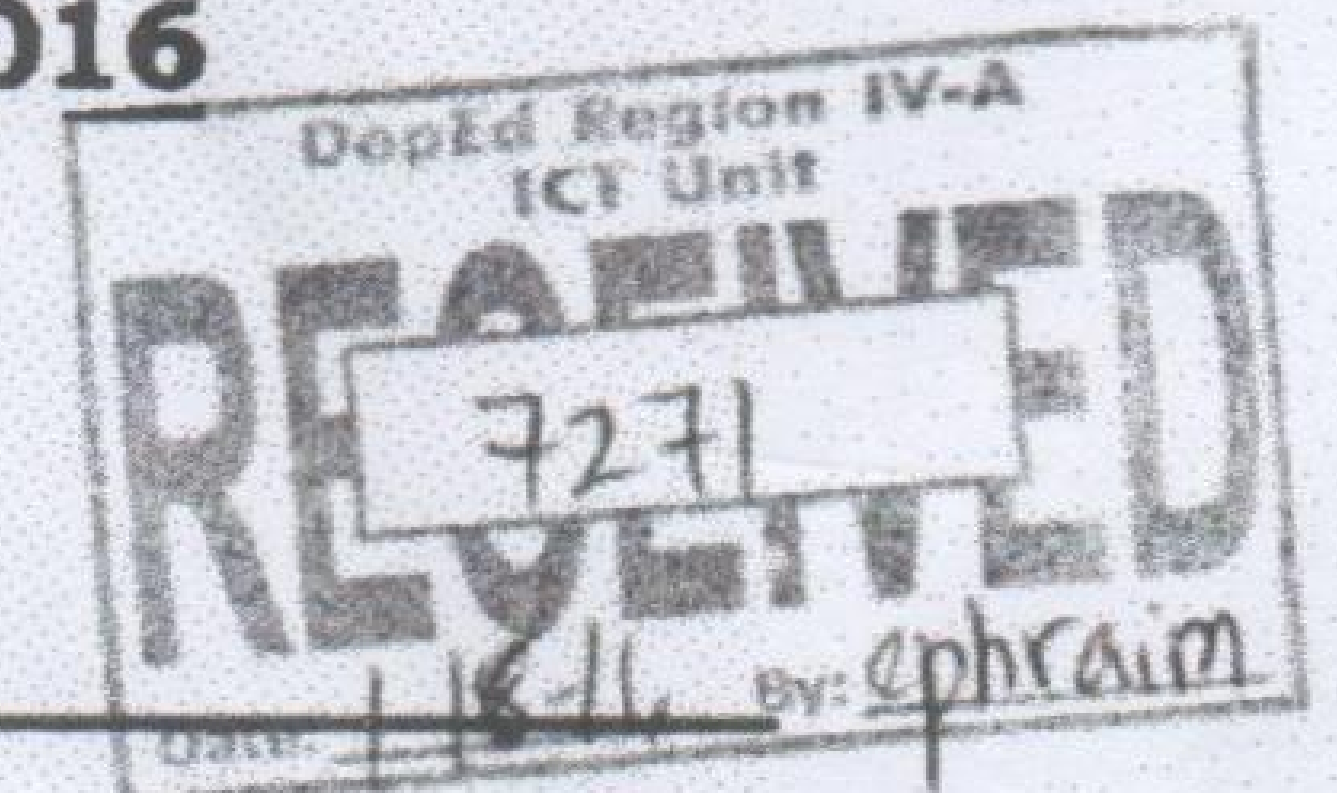
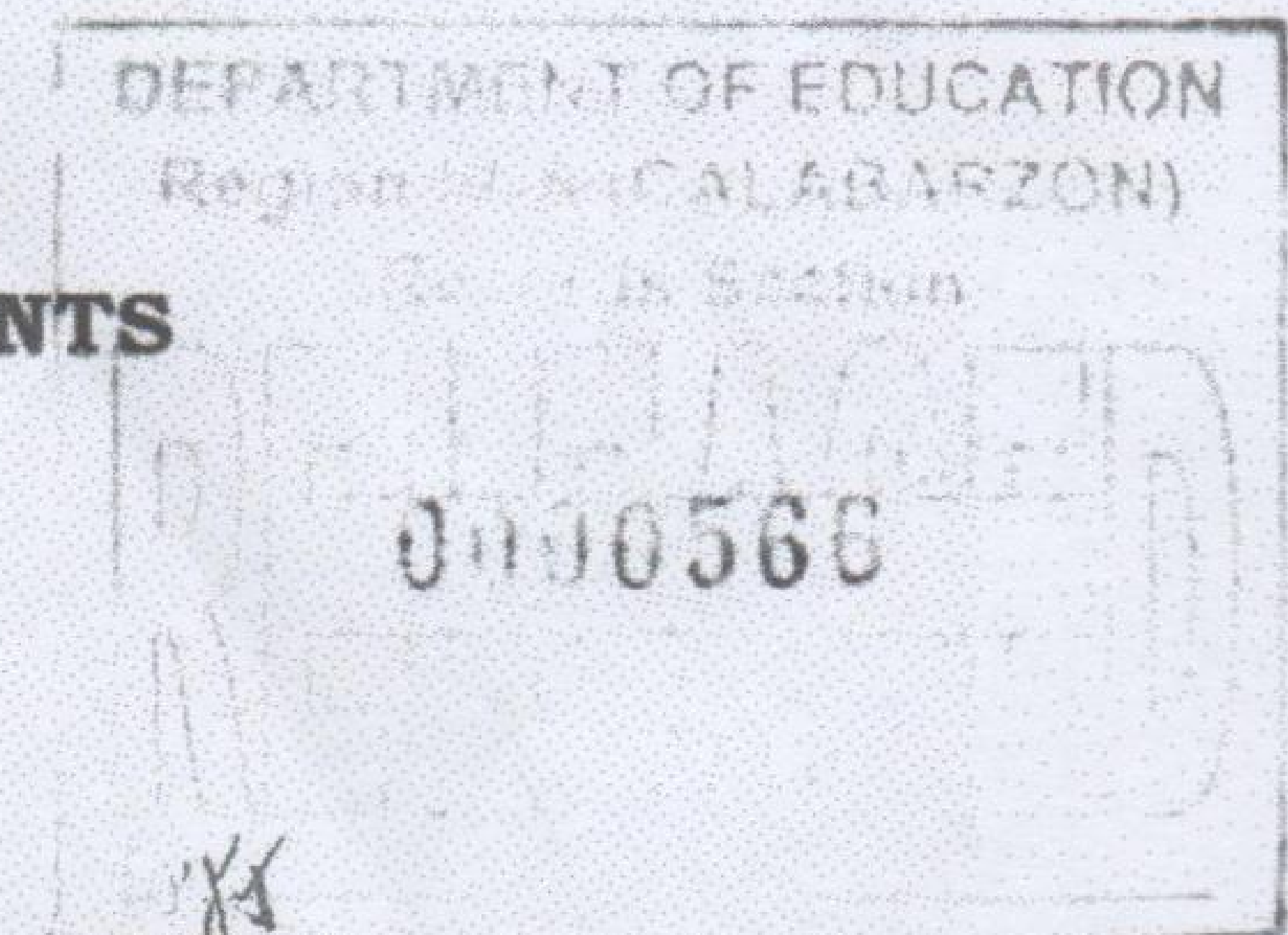

**MEMORANDUM OF UNDERSTANDING**

**CONCERNING**

**IMPLEMENTATION OF THE NATIONAL SCHOOL DEWORMING DAY (NSDD)  
EVERY JULY AND JANUARY OF THE SCHOOL YEAR**

**JAN 08 2016**

This MEMORANDUM OF UNDERSTANDING was executed this \_\_\_\_ day of 2015 by and between:

The **Department of Health**, a national government agency duly organized and existing under Philippine laws with office address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, Manila, represented by **Secretary Janette Loreto-Garin**, hereinafter referred to as "DOH";

-and-

The **Department of Education**, a national government agency duly organized and existing under Philippine laws with office address at Meralco Avenue, Pasig City, represented by **Secretary Br. Armin A. Luistro**, hereinafter referred to as "DepEd";

-and-

The **Department of the Interior and Local Government**, a national government agency duly organized and existing under Philippine laws with office address at DILG-NAPOLCOM Center, EDSA corner Quezon Avenue, Quezon City, represented by **Secretary Mel Senen S. Sarmiento**, herein referred to as "DILG";

Collectively they are referred to as "PARTIES".

WITNESSETH: That,

**WHEREAS**, the Integrated Helminth Control Program (IHCP) of the DOH prescribes deworming of children aged 1-12 years old two (2) times a year and provide the deworming drugs;

**WHEREAS**, the Local Government Units (LGU) implement the IHCP at the health centers through accommodation of children aged 1-4 for deworming on a daily basis for the Garantisadong Pambata Campaign;

**WHEREAS**, the DepEd implements the IHCP through deworming of schoolchildren aged 5-12 or Kindergarten to Grade VI (K to VI) every July and January;

**WHEREAS**, the DepEd Rationalization Plan decreased the number of human resources for health care;

**WHEREAS**, helminth infection affects children's school performance and leads to anemia;

**WHEREAS**, the DepEd needs additional human resources for health care to deworm all Kindergarten to VI schoolchildren nationwide;



**WHEREAS**, in order for all enrolled schoolchildren K to VI nationwide to be dewormed, the DOH and DILG representing the LGUs shall provide additional human resources to perform the NSDD on July 29, 2015 for the Round 1 or First Dose of SY 2015-2016 and for the next deworming rounds or doses.

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the PARTIES herein do hereby agree on and stipulate the following, to wit:

**1. SCOPE**

- 1.1. The PARTIES shall work together to implement the NSDD on July 29, 2015 and all deworming activities thereafter.
- 1.2. Any amendment or waiver of any provision found in this Memorandum shall require prior consent of the parties.

**2. RESPONSIBILITIES**

**2.1. The Department of Health shall:**

- 2.1.1. Prepare an Administrative Order (AO) for the NSDD. The AO for NSDD on July 29, 2015 shall also be followed in succeeding deworming activities.
- 2.1.2. Continue to appropriate funds to implement the deworming activities
- 2.1.3. Continue to provide the deworming drugs and ensure timely distribution.
- 2.1.4. Continue to support management of adverse events following mass drug administration.

**2.2. The Department of Education shall:**


- 2.2.1. Issue a Memorandum directing the implementation of NSDD and appropriate funds therefore following the NSDD guidelines of the DOH. The DOH AO should be followed for the next deworming activities.
- 2.2.2. Provide adequate and correct information to parents and caregivers on the benefits and possible adverse events following mass drug administration.
- 2.2.3. Shall provide feeding prior to deworming
- 2.2.4. Submit report to DOH on deworming coverage and drug utilization.


**2.3. The Department of the Interior and Local Government shall:**


- 2.3.1. Issue a Memorandum to the LGUs to provide assistance to DepEd in implementing the NSDD and all deworming activities thereafter with human resources and support drugs in accordance with the NSDD guidelines of the DOH including appropriation of funds.
- 2.3.2. Assist in the monitoring of LGUs' NSDD implementation.
