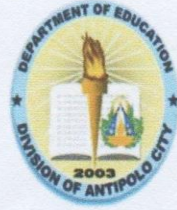

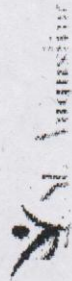
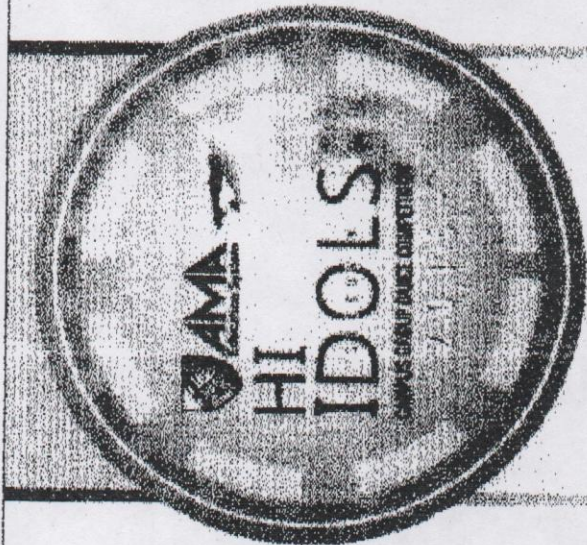
- Open to all High School students with the following combination: At least 5, 4th Year High School Students and the other 5 may compose of any year level to represent their school.

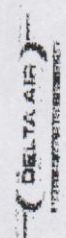
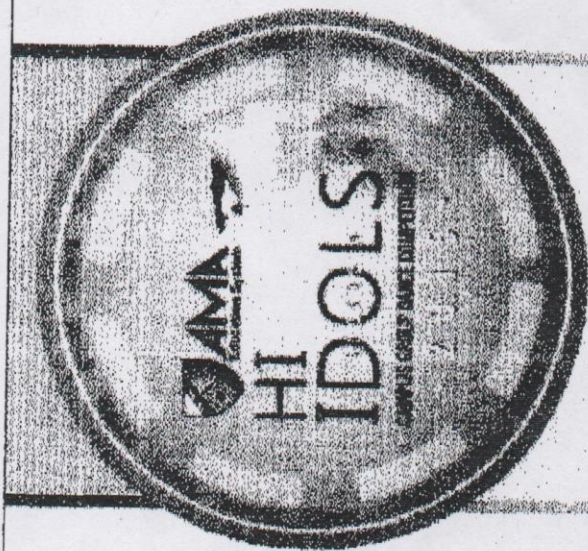
OTHER REQUIREMENTS

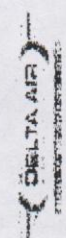
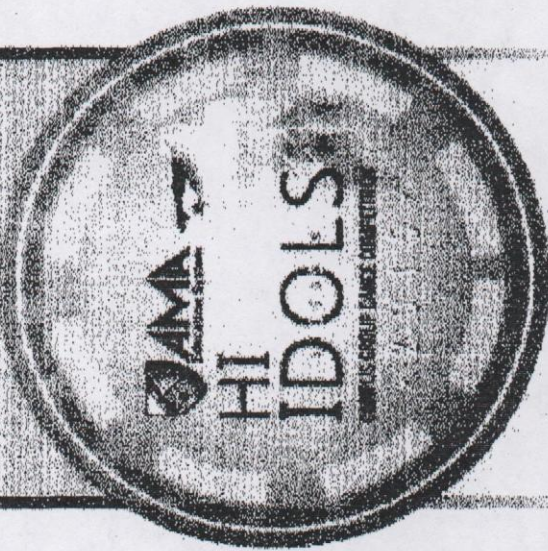
