Pursuant to Republic Act (RA) No. 10533, *Enhanced Basic Education Act of 2013*, the Department of Education (DepEd) hereby creates the **Technical Working Group (TWG) on the Assessment System of the K to 12 Program**. 5. The Sub-TWGs shall be responsible for the following:

5.1 **System Assessment**

- a. formulating an assessment framework for assessing the effectiveness of the educational system under the K to 12 Program;
- b. evaluating assessment tools/mechanisms measuring the effectiveness of the implementation of the K to 12 curriculum through internal and external measures;
- c. monitoring trends in school performance over time;
- d. proposing policy measures based on assessment results to improve educational processes and outcomes; and
- e. communicating assessment outcomes to stakeholders.

5.2 **National Assessment**

- a. formulating an assessment framework for assessing quality student learning including exit and career aptitude assessments;
- b. contributing to the policy development for system assessment utilizing student learning assessment results;


- c. determining the rate of improvement in student learning; and
- d. assessing the skills of junior high school students planning to proceed to senior high school, toward providing relevant information on their skills, abilities and readiness for academic and non-academic courses

5.3 Teachers and Supervisor Assessment

- a. formulating an assessment framework for assessing teacher competencies;
- b. evaluating of teacher assessment mechanisms and tools at different levels (i.e., department, school, district, etc.); and
- c. formulating policies in teacher assessment in collaboration with TEC and NEAP in relation to requirements set under the K to 12 system.

5.4 Classroom Assessment

- a. identifying issues on the implementation of DO No. 73, s. 2012 in the field;
 - b. re-defining formative and summative assessment in the school level including the rating system based on DepEd Order (DO) No. 73, s. 2012, *Guidelines on the Assessment and Rating of Learning Outcomes under the K to 12 Basic Education Curriculum*;
 - c. identifying models on rating system taking into consideration the applicability in local setting;
 - d. choosing and presenting an applicable rating system model to the academe and practitioners for experts' validation;
 - e. presenting the validated rating system to the Programs Committee for approval; and
 - f. revising the previous DO based on the output of the TWG.
6. The Chairperson shall convene meetings and deliberations of the National TWG and provide regular feedback to the Head of the Agency.
7. All expenses incurred by the National TWG and Sub-TWGs shall be charged to NETRC Funds subject to the usual accounting and auditing rules and procedures.
8. Immediate dissemination of this Memorandum is desired.


