

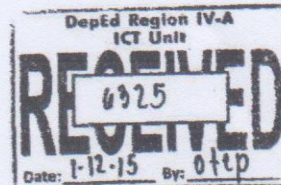

This Office invites entries for Transparent, Ethical and Accountable (TEA) Governance Logo Making Contest. Each division is enjoined to submit five official entries and should be submitted via email on or before January 30, 2015 @ [region4a@deped.gov.ph](mailto:region4a@deped.gov.ph)

Attached are the Contest Mechanics and Entry Form.

**Contest Mechanics:**

1. The contest is open to all DepED CALABARZON teachers.
2. The contest duration is from January 13-29, 2015.
3. Each division must submit five entries.
4. The logo must reflect the mantra of SCOUTERS ROCK anchored on Transparent, Ethical and Accountable (TEA) Governance of the Region.
5. Both freehand (any medium) and digital artworks will be accepted as contest entries.
6. Contest entries must be submitted in the following format:
  - a) Flat pdf format with minimum size of 12 x 12 cm minimum of 300 dpi or flat jpeg format minimum of 300 pixels
  - b) There are no restrictions in the number of colors used
  - c) A brief description or rationale of not more than 300 words explaining the components of the logo should also be included in the entry.
  - d) The logo shall not carry the name of the artist.
7. Contest entries must be submitted thru e-mail on or before January 30, 2015 to region4a@deped.gov.ph
8. Entries shall be adjudged using the following criteria:

Concept/ relevance:	40%
Originality:	30%
Creativity and impact:	<u>30%</u>
	100%
9. Winners will be chosen by a panel of judges. The winning entry will be chosen on February 6, 2015. The decision of the judge/s is final.
10. There will be three winners. They will receive the following:  
First Prize Winner -- P5,000 cash prize and Certificate of Recognition  
Second Prize Winner--P3,000 cash prize and Certificate of Recognition  
Third Prize Winner- P2,000 cash prize and Certificate of Recognition
11. Winners will be informed through Regional Memorandum and will be awarded during the 2<sup>nd</sup> Year TEA Governance Forum.
12. All entries submitted shall be considered as property of DepED CALABARZON and may be used by the Region for any other purposes.
13. DepED CALABARZON shall have exclusive rights to the winning logo design and also reserves the right to further refine and make alterations on the final artwork of the winning entry.
