This month of February, we are celebrating the Civil Registration Month with the theme "Sama Ka Sa CRVS Groupie". CRVS stands for Civil Registration and Vital Statistics. CRVS is about getting everyone registered and counted.

The Department of Education (DepEd), is one of the government agency that supports civil registration by requiring every student to submit copy of his certificate of live birth.

In this regard and as part of the advocacy of PSA Region 4A, we strongly encourage that certified true copy of birth certificates issued by the Local Civil Registrar within the region be accepted for enrolment purposes of incoming kindergarten or Grade 1 student. It is our firm belief that CTC issued by the local civil registry offices in the region is the same copy available in the PSA database.

We also suggest that school principals coordinate with the Local Civil Registrar in the city/municipality where the school is located to avail of free issuance of copies of birth certificates of enrolling students
