

City Ordinance No. 2014-605

WHEREAS, on 2 September 2013, the members of this august body approved City Ordinance No. 2013-533 entitled, "An Ordinance authorizing the grant of honoraria for public elementary and high school teachers and qualified non-teaching of DepEd personnel assigned in the City, and for other purposes";

WHEREAS, pursuant to the aforesated mandate and in recognition of the invaluable roles performed by this city's public school teachers in the promotion of quality education for the constituents of this city, this august body has deemed it necessary to revisit the earlier approved measure and include such requirement of residency to all teaching and non-teaching DepEd Personnel assigned in the City;

WHEREAS, an amendment is therefore necessary to include such a requirement in the grant of honoraria for public elementary and high school teachers and qualified non-teaching DepEd personnel in the City, in this case, its required employment for one (1) year as hereunder stated.

NOW THEREFORE,

BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF ANTIPOLO IN SESSION ASSEMBLED, THAT:

SECTION 1. For purposes of this Ordinance, Section 2 of City Ordinance No. 2013-533 is hereby amended to read as follows:

x x x

SECTION 2. HONORARIA. There is hereby granted a monthly honoraria of One Thousand Five Hundred Pesos (P1,500.00) for all public elementary and high school teachers personnel of the Department of Education assigned in or stationed in the City. Provided, that the grantee is presently employed and has continuously rendered service as such for one (1) year.


SECTION 2. All ordinances, resolutions, rules and regulations which are inconsistent herewith are hereby repealed, amended and/or modified accordingly.

SECTION 3. This Ordinance shall take effect upon its approval.
